

The Education Committee had a busy Q1 and Q2 as it awarded a total of 5 Chicago RIMS Chapter scholarships for \$2,500/each to students. Scholarship recipients included University of Wisconsin students Alex Coffini and Case Winter, as well as Illinois State University students Jacob Gordon and Sejal Pamnani. For the first time in RIMS Chicago Chapter history, we awarded a \$2,500 scholarship to a student who shares our dedication to the Diversity, Equity and Inclusion (DEI) Chapter initiatives. The inaugural DEI scholarship was awarded to Natalie Maruyama from the University of Wisconsin.

Steve Boss from the Education Committee attended the Katie School Advisory Board meeting, scholarship award ceremony and Katie School Hall of Fame event in April at Illinois State University. We continue to explore opportunities to assist RIM programs in the Midwe<mark>s</mark>t with education and mentorship opportunities.

DIVERSITY, EQUITY & INCLUSION

In the second quarter, RIMS DEI focus was front and center at this year's Global RIMS RISKWORLD conference held in Atlanta! This year, the conference featured a whole tract of programming focused on thought leadership, networking and relationship building between RIMS and external organizations that are promoting increase diversity in the insurance profession. Ahead of this year's conference, RIMS announced a partnership with NAAIA (National African American Insurance Association) which was exhibited with NAAIA's strong presence throughout the conference. In one of the sessions, NAAIA's Executive Director, Omari Jahi Aarons and Dr. Leroy D. Nunnery II (Evolution Advisors, LLC) and Renee Collins (Travelers) reviewed the second installment of the research on African American professionals in the risk and insurance industry: "The Next Steps on the Journey: Has Anything Changed?". As the panelists reflected on the report's findings, it only continued to highlight opportunities for our committee to help provide growth opportunities, find other ways to be change agents and making the risk and insurance industry more accessible and equitable to all. 2023 RISK MANAGER OF THE YEAR

Theresa Severson Vice President. Insurance and Risk Management

She has over thirty years of experience in risk management and is currently Vice President of Insurance and Risk Management at Kite Realty Group (KRG). Theresa is also committed to ensuring a bright future for risk management as a profession, by hiring interns with the assistance of the Spencer Educational Foundation and through personally providing mentorship and support to many others in risk management and related fields.
